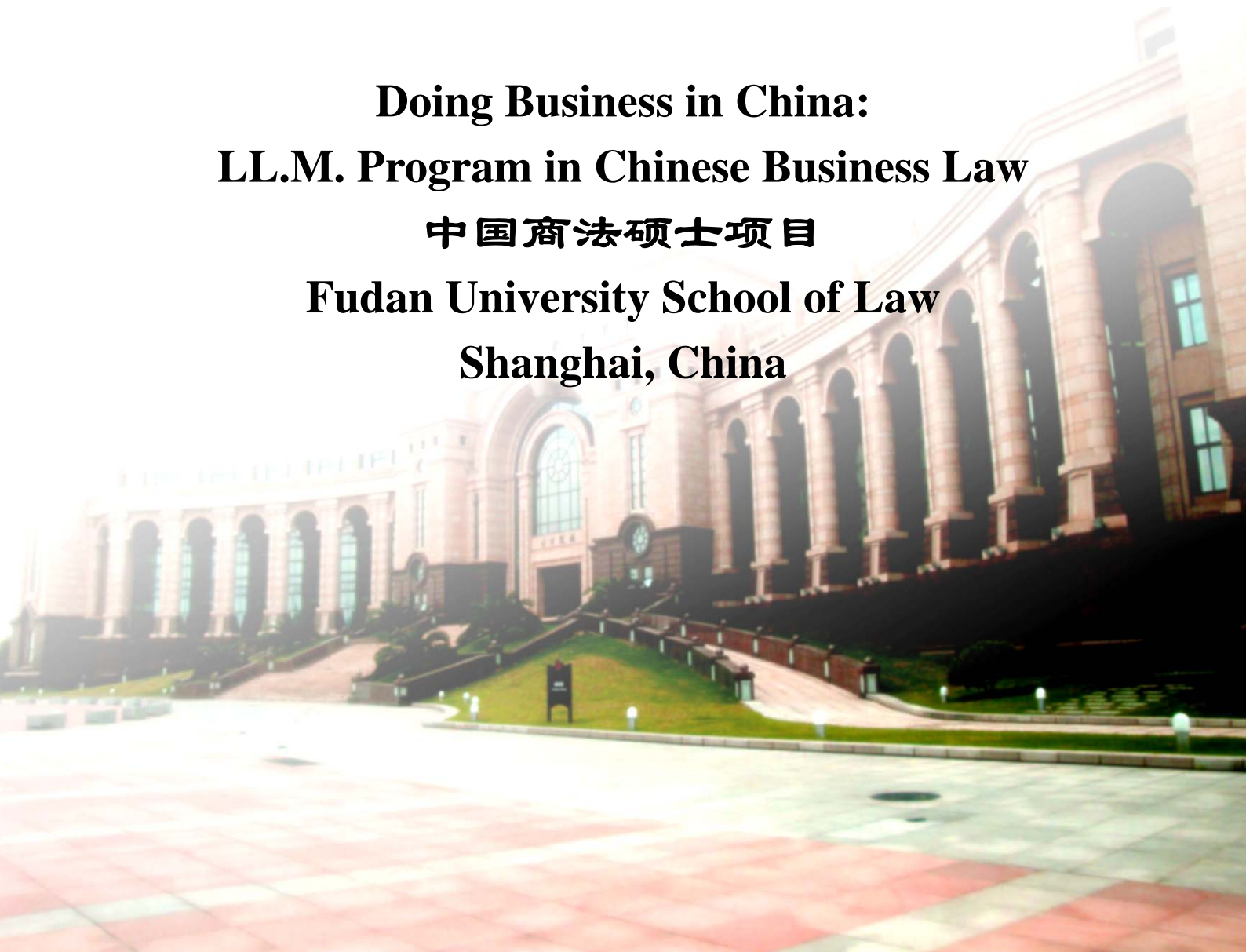

FUDAN UNIVERSITY SCHOOL OF LAW

Being a preeminent and prestigious university in China with over 100 years' history, Fudan University is located in Shanghai, the largest city and commercial/financial center of China. The history of her School of Law can be traced back to the late 1920s. Through the efforts of her faculty in over 80 years, the School of Law has become one of the leading institutions for legal education in China. The developed economy, high educational level, rich human resources, sound legal environment, and the unique economic status of Shanghai have long required Fudan University School of Law to educate students focusing on business and financial law; therefore, the School of Law has developed a very strong academic faculty in this field. She has provided numerous graduates to the government, courts, law firms, business corporations, law schools, and other institutions, and has established close links with many foreign leading law schools. Each year, there are many foreign students enrolled in the various programs at Fudan University School of Law.



LL.M. PROGRAM IN CHINESE BUSINESS LAW

Since fall 2010, Fudan University School of Law has launched her LL.M. (Master of Laws) Program in Chinese Business Law to foreign lawyers, executives, students, and professionals engaging in international trade and/or interested in Chinese business and financial law. The language of instruction is English.

If you are a non-Chinese citizen or an applicant from Hong Kong, Macau, and Taiwan of China, have received a first college degree, and have good command of English, you are eligible to apply. LL.M. degree will be granted to the candidates who have successfully completed the required course work, and fulfilled the requirements for a dissertation.

The LL.M. Program in Chinese Business Law requires the students to complete two-semester course study for 30 credits. The fall semester will be from August to December, and the spring semester from February to June. After completing the course study, the students need to submit a dissertation and pass the oral defense within two

years since the enrollment in order to receive the degree. The students may complete the dissertation at Fudan, or at any other places as long as they return for the oral defense. The students who have successfully completed one or two semesters' course work but decide not to write the dissertation will receive a certificate.

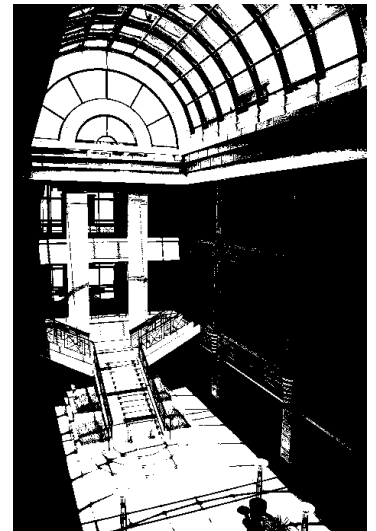
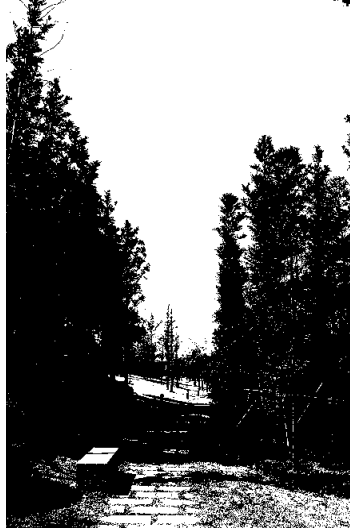
Each LL.M. student will be assigned an academic mentor/advisor for study and dissertation writing, and a Chinese student will be introduced to be their "buddy" to help them familiarize with the life in Shanghai. In addition, the School of Law will arrange regular academic and non-academic activities for both the foreign students and Chinese students so that they may communicate with and learn from each other.

Credits earned in the LL.M. Program by students from a foreign partner law school under an exchange agreement with Fudan University School of Law are transferable according to the agreement and the home school's policy.

CURRICULUM

The LL.M. Program in Chinese Business Law is carefully designed to offer students a thorough grounding in Chinese business law and business-oriented topics:

TUITION AND OTHER COST

The tuition fee for the program is RMB 160,000 yuan, with 80,000 yuan to be paid in the beginning of each semester. The application processing fee is RMB 800 yuan and is non-refundable.

During the 2-semester residency period, students may be housed in the on-campus dormitory rooms for international students or off-campus rental houses. Students may have meals at the various canteens/cafeterias on campus or other off-campus restaurants which offer delicious food at a reasonable price. Students will cover their own housing, meal, health insurance, and transportation costs and will be responsible for the cost of textbooks for the program. FINANCIAL AIDS AND SCHOLARSHIP

Fudan University School of Law provides both financial aids and Fudan Law Scholarship (FLS) to the students of the LL.M. Program in Chinese Business Law. The financial aids which may be up to RMB 5,000 yuan will be granted to students on the need basis. Students may submit application after registration. The FLS which may be up to RMB 12,000 yuan will be granted to students on the merit basis. All the students who have passed the final exam of the first semester are eligible to apply for the FLS.

APPLICATION AND ADMISSION



Eligible applicants must be non-Chinese citizens or from Hong Kong, Macao, or Taiwan of China, who have completed college study and received a bachelor's degree from a qualified college or university. The applicant whose native language is not English must prove his or her English proficiency, e.g., possessing a TOEFL score above 92 ibt or a IELTS score above 6.5.

A completed application requires:

1. Fudan University Application Form for International Students (<http://iso.fudan.edu.cn/en/index.htm>);
2. A resume in Chinese or English;
3. Personal statement in Chinese or English;
4. TOEFL or IELTS report;
5. College diploma, degree certificate, and transcripts;
6. A photocopy of a valid passport;
7. Two letters of recommendation from two professors; and
8. Application fee (\$120 or RMB 800 yuan).

All documents must be in Chinese or English. If the original document is in a language other than Chinese or English, the applicant shall provide a notarized translation in either Chinese or English.

Application deadline for degree students is June 10; application deadline for non-degree students is July 10 (fall semester) and December 10 (spring semester). Send your application to:

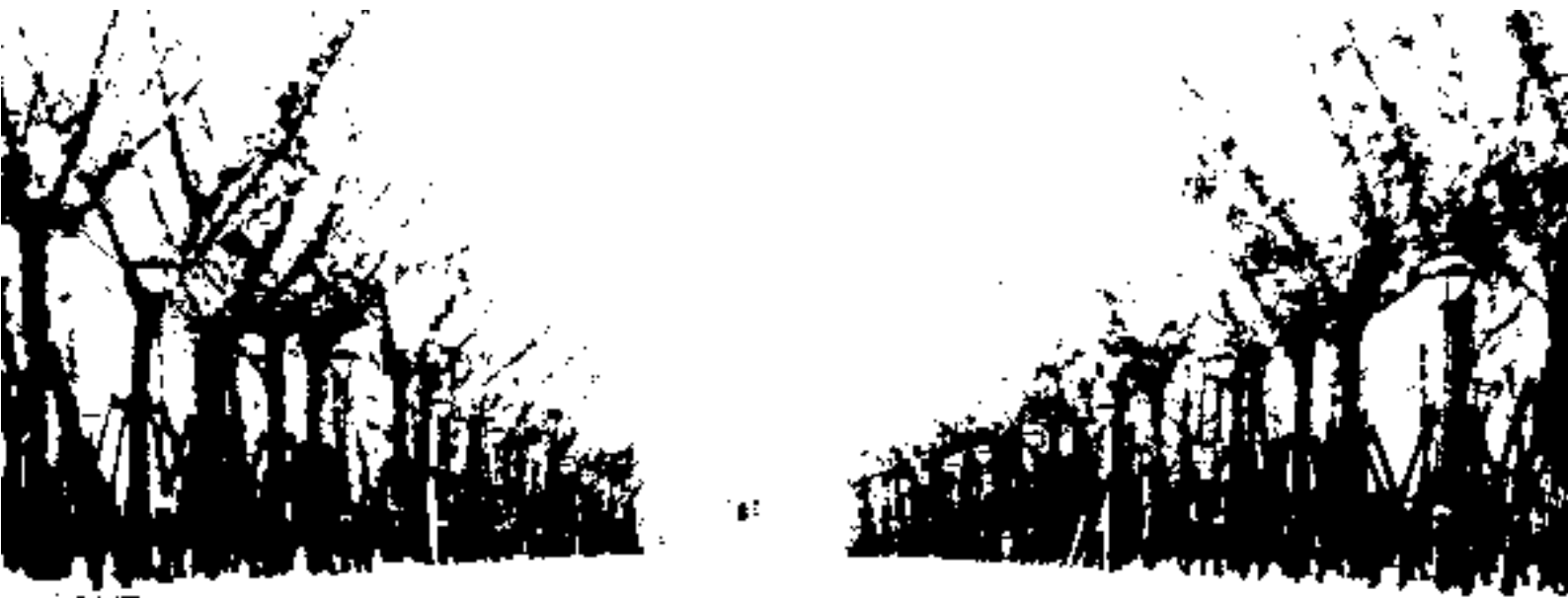
